

OUR PURPOSE

With the support of our donors and volunteers, our grants help when TRADITIONAL funding falls short or is not available to a family facing financial hardship due to illness or UNIQUE circumstances.

A volunteer presented us with a grant application for Nicholas. For the past two years, the family has been working hard to raise the funds necessary to obtain a service dog. He is a vibrant 5 year old boy with Angelman Syndrome, a rare genetic disorder that affects the nervous system. CTCF has granted the family the remaining funds necessary to obtain a service dog, as well as travel expenses associated with the training session for the family. The family is now on a waiting list, awaiting a perfect match for a companion dog.
